Terms of reference

Selection of Trainers for the Project "Improvement of Port Customs and Operations Efficiency in Africa"

The Fondazione Accademia Italiana della Marina Mercantile is currently implementing the project "Improvement of Ports' Custom and Operations Efficiency in Africa".

The project is funded by the ACP Secretariat and the European Union and is implemented by a partnership composed by:



The Fondazione Accademia Italiana della Marina Mercantile (FAIMM), based in Genoa, Italy



The Académie Régionale des Sciences et Techniques de la Mer (ARSTM), based in Abidjan, Ivory Coast



The Port Management Association of West and Central Africa (PMAWCA), based in Lagos, Nigeria

The project objective is to:

• promote the implementation of Port/Maritime Single Window systems in ports of Western and Central Africa (WCA) through the provision of training and capacity building to personnel.

In this sense, the project shall implement capacity building aimed at improving the knowledge and expertise in 7 African Countries of Port Community Systems/Maritime Single Windows ie. IT-based systems involving all actors of a port community with the aim of facilitating the operations of maritime trading by providing a single channel for exchange of informations within the port and with maritime trade actors (terminal operators, shipping companies, public authorities etc.)

The project will implement the following crucial activities:

- implementation of a **medium-term training** for employees of ports and other institutional actors of port communities, lasting approximately 7 weeks and to be held in Abidjan during the first half of 2020. Trainees from 7 ports will receive training in all aspects of development and implementation of Maritime Single Window.
- Implementation of **short-term training sessions** in ports, open to all public and private stakeholders, to be held during the second half of 2020 on the initiation and management of the process to implement Maritime Single Window;

Scope of the Assignment

FAIMM intends to contract experts to implement capacity building activities in the project, namely:

- Activities linked to Work Package 2-Capacity Building:
 - o Development of a mid-term training plan and materials for 20 beneficiaries, which include the participation to meetings in Lagos and Abidjan as well as 6 Collaborative Fora lasting one day in target ports of the region
 - o Delivery of the mid-term training along a period of 7 weeks
 - o Provide support to local experts in the development of short-term training sessions to be realised in their own ports
 - o Be mobilised on a on-need basis for delivery of short-term training in the ports of the region
- Activities linked to Work Pckage 3 of the project- Capitalisation
 - o Provide support in the development of a grant scheme for implementing small scale actions in support of Maritime/Port single window implementation in 7 ports of the region
 - Provide support in evaluation of proposals and implementation of the actions.
 - o Provide support to the modelisation and e-training development based on WorkPackage 2 activities.

The Selection is open to companies providing expertise. Companies may propose more than one person for each profile but, in any case, one of the experts must be compliant with the whole profile.

The Fondazione Accademia della Marina Mercantile will maintain the management control of the training activities.

In this sense, the following conditions will apply to experts:

- the Experts will work under the instructions/supervision of the beneficiary;
- Payment to the expert or the company that contracted him/her will be done upon presentation and approval of time sheets and narrative reports in annex to the present document
- the experts will have to implement most activities in the premises of the Fondazione Accademia Italiana della Marina Mercantile or in the premises of the project beneficiaries as a member of the project team;
- the output of the work will belongs to Fondazione Accademia Italiana della Marina Mercantile;
- travel and subsistence costs will be directly paid by the Fondazione Accademia Italiana della Marina Mercantile. Activities to be implemented

The activities to be realised by the experts include:

Mid-term Training

The mid-term training shall represent the core of the IPCOEA project. It is targeted at, at least, 20 persons: (2 persons each from 7 countries, 2 persons from PMAWCA, 3 persons from ARSTM)

Objective of the Mid-Term Training:

the objective of the mid-term training is to deliver the following result envisaged under the IPCOEA Logical Framework Matrix:

At least 15 professionals with improved capacity to design and manage technical assistance for implementing single window approach and establishing Port Community Systems [ie develop and implement a Maritime Single Window] through medium-term training

Tasks for the realisation of the Mid-term Training

The tasks for the realisation of the mid-term Training are divided in:

- The preparation of the Training
- The delivery of the training sessions

Preparation of MT training Description

The preparation of the training shall be realised by a team of experts through work from home and implementation of meetings among themselves and with port personnel

The preparation of the training materials will require the following inputs in specialised in-house consultants:

- Implementation of 2 missions to Africa (in Lagos and in Abidjan) for 1 specialised expert (Technical Maritime Capacity Building Expert) for a total of 10 Working Days
- Implementation, in coordination with the cooperative forums to be organised by PMAWCA, of 7 short missions of 3 WD each of specialised experts, for a total of 21 Working days.

Furthermore, at least 1 Port Operations expert, providing inputs on actual operation and inspections in African ports and 1 Maritime Trade and Customs expert, with specific expertise inimplementation of the ECOWAS Common External Tariff shall be mobilised by ARSTM for the development of the training. The inputs of the specialised experts shall be complemented by inputs of internal personnel of the FAIMM, the ARSTM and the PMAWCA, especially for development of the training plan and for the development of supporting training documents

Short-term Training

The Short-term training shall represent the main isntrument to disseminate the skills in the target area of the IPCOEA project. It is targeted at, at least, 100 persons: (15 People each in 7 countries).

The short-term training shall lead to the dissemination of needed expertise to formulate a planning for MSW implementation in ports of the region to be enshrined in the adapted toolkit.

Objective of the Short-Term Training:

the objective of the short-term training is to deliver the following results envisaged under the IPCOEA Logical Framework Matrix:

At least 100 Port beneficiary staff operating in ports' customs services have improved their knowledge of most efficient practices for custom and administrative clearance procedures and rules set by international instruments such as the EU-WA EPA and the West Africa CET

At least 7 Ports with available planning for MSW implementation in the region

Tasks for the realisation of the Short-term Training

Preparation of ST training

Financing of Pilot Actions

The pilot actions are the prime instrument for allowing immediate capitalisation of the results of training

The project will make available to port communities up to a total of 7 small-scale grants for financing actions with a global cost up to 60.000,00 Euros. A co-financing from port communities of 20% of the costs will be required. This means that EU contribution per project can be up to 48.000Euros.

Grants may be used by third parties to implement actions aimed at supporting the implementation of a single window approach in ports. A call for proposals will be launched with the objective of "Promoting the implementation of a single window and/or Port Community System approach in ports of the ECOWAS region, capitalizing on the results of the IPCOEA project activities".

The following types of actions may be financed (non-exhaustive list):

- Promotion of inter-agency cooperation structures within the port community through joint study and planning of activities between public bodies;
- Co-financing of joint acquisition of IT equipment and/or services;
- Joint studies on implementation of global best practices for single window/PCS in the port.

Eligibility of costs will follow the same rules defined by the present grant scheme. The management of the grant scheme will be carried out by the project manager, the assistant project manager and the two partner administrative officers, in accordance to rules set for the Intra-ACP envelope of the EDF.

Financing of Pilot Actions

Trainers and internal personnel

The grant scheme will be developed and implemented by FAIMM personnel.

Technical inputs from the experts contracted under the present procedure will be necessary to develop the grant scheme guidelines and evaluate the proposals, for a total of 50 Wds of experts.

- Dissemination of the call for proposals
- Administrative assistance to applicants
- Collection of proposals
- Evaluation and selection of 7 proposals
- Negotiation of contracts
- Monitoring implementation of contracts
