



**MODULE FOR THE AUTHORISATION RELATED TO THE PRIVACY AND AGREEMENT OF
THE CONSULTANTS FOR THE TREATMENT OF PERSONAL DATA PURSUANT DATA PRO-
TECTION THE GENERAL RULES
(UE 2016/679)**

Pursuant to and for the purposes of the Regulation in question, we inform you that the personal data communicated by you, concerning your person, are collected, recorded, organized and, in the event of the conclusion of the collaboration engagement, stored and included in our electronic database - of which our Foundation is the owner - exclusively for the purpose of fulfilling the obligations deriving from the stipulation of the engagement and the administrative procedures for issuing / managing invoices.

There is no obligation to communicate the requested data but the same are essential for the regular development of the relationship and, if they were not communicated to us, it would be technically impossible to carry out the agreed job relationship. The data may possibly be disclosed to third parties, to competent authorities or to entitled entities, as well as, in the event of disputes, to our trusted lawyers.

In addition to the Data Controller, the Data Processor and the persons in charge of the Secretariat and Administration service may become aware of the data in the capacity of Data Processors, each with regard to the duties of their competence.

We also inform you that you have:

1. the right to obtain confirmation of the existence or not of its own personal data, even if not yet registered, and their communication in an intelligible form.
2. right to obtain indication a) of the origin of personal data; b) the purposes and methods of the processing; c) of the logic applied in case of treatment carried out with the aid of electronic instruments; d) the identity of the owner, manager and the designated representative; e) the subjects or categories of subjects to whom the personal data may be communicated or who can learn about them as appointed representative in the State, managers or agents.
3. right to obtain a) updating, rectification or, when interested, integration of data; b) the cancellation, transformation into anonymous form or blocking of data processed in violation of the law, including data which need not be kept for the purposes for which the data were collected or subsequently processed; c) the statement that the operations referred to in letters a) and b) have been brought to the attention, also as regards their content, of those to whom the data have been communicated or disseminated, except in the case in which this fulfillment is impossible or involves the use of means manifestly disproportionate to the protected right.
4. right to object, in whole or in part a) for legitimate reasons to the processing of personal data concerning him, even if pertinent to the purpose of the collection; b) to the processing of personal data concerning him for the purpose of sending advertising or direct sales material or for carrying out market research or commercial communication.

These rights are exercised with a request addressed without formalities to the owner or manager, also through a person in charge, to whom suitable feedback is provided without delay.

Finally, we inform you that at the bottom of this document you are asked to authorize the Accademia Foundation to use your image.

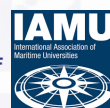
