Economical Agreement

Given that

- The Fondazione Accademia Italiana della Marina Mercantile (FAIMM) is a public institution providing specialist training at post-secondary level in the maritime field. The Fondazione Accademia Italiana della Marina Mercantile is located in Via Nicolò Oderico 10 – 16145 Genova, Italy; for the signature of this agreement the FAIMM is represented by its Director, Dr Paola Vidotto.
- The Business College of Athens proposed to the Italian Shipping Academy an interesting program in Hospitality, Food and Beverages, mainly aimed to the academic and professional development of Italian Shipping Academy Ship Purser Cadets (Commissario di Bordo);
- In 2023 the Parties entered into an academic cooperation agreement for the admission to BCA-GIME College for FAIMM cadets, currently valid.

The Foundation and Business College of Athens hereinafter referred to individually as the "Party" and jointly also as the "Parties", with the signing of this agreement

Agree as follows

Art 1 – Permisses

1. The premises indicated above form an integral and substantial part of this agreement.

Art 2 – Objectives

1. The Parties jointly intend to promote and develop a study project dedicated to n. 6 students from The Italian Shipping Academy Foundation for the days from 1st of april to 13th of april 2025.
2. The educational purpose of the Project is to introduce the participants to an intensive experience in Hospitality, Food and Beverage. The project includes a total amount of 86 hours of lesson.
3. The complete and updated program is proposed by BCA and is to be considered an integral part of this agreement (annex 1).

Art 3 – Responsible for the agreement

1. For the management of the activities, the Parties designate a contact person with the task of guaranteeing constant support for the entire duration of the project in case there is a need.
For FAIMM : Paola Strata
For BCA GIME: Christine Kostantinidou

Art 4 – Parties' obligations

BCA is obliged to:

- Provide FAIMM with the detailed program of the Project assuming responsibility for the implementation of the training activities and services indicated therein.
- To comply with all that is foreseen and agreed in advance through the proposition of the program which, approved by both parties, must be considered an integral part of this contract.
- Guarantee the participating students INAIL and RC insurance coverage for the entire duration of the project.

FAIMM is obliged to:

- Promptly provide the names of the students who will take part in the project as well as all the information necessary for BCA to manage and organize the project;
- Guarantee the payment of the budgeted costs for the project in the manner and times set out in the following art. 7.

Art 5 – Room and board

The management of board and lodging will be the responsibility of FAIMM; board and lodging are not covered by this agreement.

Art 6 – Medical health insurance

Each participant must be covered by suitable medical health insurance valid from the moment of arrival and thus for the entire duration of the project.

Art 7 – Costs and payment methods

1. The total price for the Project – which includes the total of 86 hours of lesson - is € 15.000,00 – all taxes included.
2. The payment conditions provide for the payment of the amount upon presentation of a specific invoice by the BCA starting from 13 April.

Art 8 – Duration

This economical agreement will be effective until the end of the planned activities, unless terminated in advance pursuant to this article.

This agreement may only be modified by a revision or modification in writing.

Considering that the participants have already booked flights and accommodation, this agreement cannot be terminated except in cases of force majeure not attributable to the terminating party (art. 9).

Art 9 – Unforeseeable circumstances and force majeure

1. In the event that events beyond the control of the parties should occur (epidemics, pandemics, wars, etc.) capable of preventing the implementation of the Project, neither FAIMM nor the BCA will owe anything.

Articolo 10 – Safety

1. BCA - as a host - assumes all the obligations relating to the application of the rules on health and safety in the workplace towards its own staff, external staff and the students/trainees who will be hosted.

Art. 11 - Disputes

1. Any dispute must be resolved amicably between the parties.
2. In the event that the Parties fail to find a conciliatory hypothesis, the Court of Genoa will be competent.

Art 12 – Treatment of personal data and Confidentiality

1. The data processed in execution of this agreement will be used only for institutional purposes in compliance with the current regulatory provisions for the protection and confidentiality of data and information. The Parties will treat the confidential information received from the other Party in full compliance with EU Regulation 679/16.
2. The Parties undertake, through appropriate procedures, not to bring to the attention of third parties information, technical data, documents and news of a confidential nature, concerning the other Party which they become aware of under this agreement.

Art. 13 – Quality System

1. FAIMM acquires the Quality Management System developed by BCA, for which the General Management is responsible, with the operational collaboration of the Quality Manager, also with a view to adapting to the provisions of the STCW.
